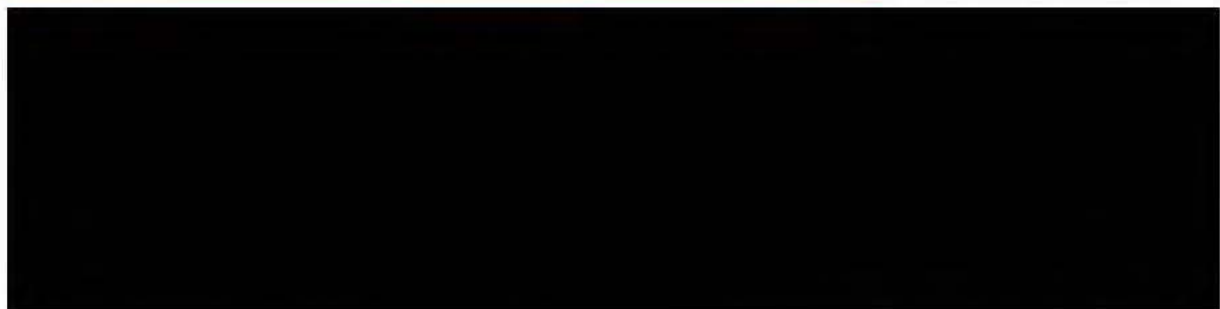

Thanks for sight of this – and to **** for this morning's conversation, and ***** for your emails. I share your concerns about the content, the impact and the need to both reassure it has been dealt with directly, as well as lessons taken from this around how material is constructed and checked.

I have checked-in with Professionalism/L&D and with other colleagues at NSY, and I am reassured that the impact is well understood and action being taken. I hope that you have the same sense.

On the need to look systematically at this – something I know the SSAs have raised – I know this is addressed in the letter you received and points to a response which is less, well, 'responsive' and more about engaging to create the content we really want.

It's going to be important for CPIE and L&D to play their part in responding – which hopefully is the most direct route to action. I've copied in Commander Helen Harper. I know some of the L&D leads are away this week.

I don't know whether you will be at the NAMP meeting that ***** is inviting me to? But rather than set up something different, would that be an opportunity to speak again on this?
