The acceptance of such support does not make any of the obligatory or statutory functions of MOPAC and/or the MPS totally or partially dependent on the provision of the support.

By the provision of this support, you accept that:

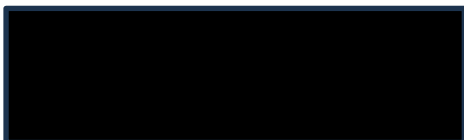
- Neither your organisation nor anybody acting for your organisation shall give the impression of representing or being in any way connected with MOPAC or the MPS other than by the support.
- By accepting the support neither MOPAC nor the MPS endorses the business or any products of your organisation, although it is understood and agreed that the MPS may inform third parties that the support from your organisation is being used by the MPS and the subsequent benefit to the initiative being supported.
- Your organisation shall not use MOPAC's or the MPS's name or logo nor release any publicity statement in connection with the provision of the support without our prior written consent.
- Your organisation shall not act in any way which is likely to be detrimental to the initiative which has been organised by the MPS using the support or is likely to cause damage to the reputation of the MPS in the eyes of the general public.
- Your organisation shall not offer to give, agree to give or give to any person employed by, appointed by or representing the MPS or MOPAC, this support, or any gift, loan or donation as an inducement or reward to do any act to show favour or disfavour to any person.

- The acceptance of the support shall not prevent MOPAC from undertaking any competitive process to source and secure a comparable product in the future.
- The acceptance of the support shall not provide your organisation with any presumption or likelihood of success during any procurement process undertaken by MOPAC.
- Your organisation should be aware of its responsibilities pursuant to, and adhere to the Prevention of Corruption Acts 1889 to 1916 and the Bribery Act 2010 when offering support. Your organisation must also be aware of the fact that MOPAC has obligations pursuant to the Freedom of Information Act 2000 and Elected Local Policing Bodies (Specified Information) Order 2011 and the provision of this support will be privy to public scrutiny.
- MOPAC is not offering or providing any exclusive opportunity to your organisation.
- The provision by your organisation, and acceptance by MOPAC, of the support shall not constitute any partnership between any of the parties or be deemed to have created any relationship of agency between the parties and neither party shall have MOPAC to contract on behalf of or otherwise bind the other in any way.
- Your organisation shall ensure that anything provided as part of the support is fit for the purpose for which they are provided, comply with all applicable laws and standards and is free from material defects.
- By providing the support, your organisation agrees that MOPAC will become the lawful owner of the items provided by your organisation or purchased by MOPAC with a monetary donation; will use the items as it sees fit including the professional judgement of any police officer using the items; and has the entitlement to use, pass on, sell or otherwise dispose of the equipment, materials or other items in line with our existing policies.

If you understand and accept the terms under which the Mayor's Office for Policing and Crime can accept your support, we shall be happy to receive it. Please sign and date below, return the letter and keep a copy for your own records.
